From the Glendale Police Department and Los Angeles County Police Chief's Association:

Bail Schedules

On July 18, the Superior Court of Los Angeles County approved a new set of bail schedules for suspects arrested in non-violent felonies and misdemeanor crimes. The new bail schedule, slated to take effect in LA County on Oct. 1, will dictate one of three possible actions by law enforcement for an arrestee's release: Cite and Release (CR), Book and Release (BR) or Magistrate Review (MR). Capital offenses, such as murder with special circumstances and limited felonies, are not eligible for pre-arraignment, zero bail release.

The Sheriff's Dept. and all police departments in the County must comply with this protocol.

The newly approved Release Protocols will replace the traditional bail schedules. Instead of assigning money bail amount to non-violent felonies and misdemeanors, a majority of arrestees will now be released at the location of the arrest (CR) or booked in jail and then released on their own recognizance with a citation for a future court date (BR). In some cases, suspects arrested for certain crimes which pose an increased risk to the public will be referred to an on-call magistrate who will have discretion to determine the appropriate release terms and conditions (MR). Some examples of release conditions by a magistrate may include prohibitions against committing crimes, sending text messages to remind the arrestee to appear in court and visits with court staff.

As a result of these new release terms, law enforcement must Cite and Release or Book and Release arrestees in nearly all theft offenses, vehicle code violations, and crimes against property, such as petty theft and vandalism. Offenses involving guns, sexual battery, crimes

The neighbors in the 3000 block of Frances Avenue have been voicing their concerns regarding a new neighborhood business.


U Matter Luxury Resort purchased a home on a large parcel in the area and has created an oasis for "detox."

9/11 Motorcade that remembers, honors and respects the memory of those who perished on Sept. 11, 2001. The motorcade was the creation of the CV Chamber of Commerce and one of its longtime members and contributors Jean Maluccio and the Early Rodders. Jean died last year and this year's motorcade was also held in her memory. She, with fellow Chamber board members and members of the Early Rodders, wanted to create an event that commemorated the events that happened Sept. 4 CV Weekly celebrated 14 years of across our nation on 9/11/01.

#### Taking A Look Outside Our Window

Friday, Sept. 8, was Star Trek Day. I had no idea it was Star Trek Day until a fellow Trekkie reached out to share the celebration. Quite honestly I thought every day was Star Trek Day because there is not one day that I don't see a reminder of one of its many episodes. From the Shakespearian tragedy that is our present political landscape to the terrifying "planet eating" weather issues, "Star Trek" can be related to everything that happens.

So on Sept. 8, 1966 "Star Trek" – the original and most perfect - series debuted with its pilot "The Man Trap." It was the first time we would hear Captain James T. Kirk (William Shatner) say those words: "Space – the final frontier."

I am not a child who watched this series when it was on in prime time but my cousin was a fan. He watched the original series during its brief three-year run. It was canceled on June 3, 1969. There has been a lot of hype about the multiple spin-offs, and I have watched them all; as a loyal Trekkie, I feel it is my duty to support. But in a special that was on television to commemorate Star Trek Day a lot of time was spent advertising Paramount Plus and the numerous "Star Trek" spin-offs; however, very little time was spent on the reason why, after 57 years, we are still talking about "Star Trek."

As I stated, the original series was canceled after only three years and for most series that would be the end; however, to say "Star Trek" found a new life in reruns would be an understatement.

This series didn't just capture the imagination of the viewers; it also gave people a positive look at a future when there was very little positivity in the world. Creator Gene Roddenberry showed us a world that could be, where diversity was not something that had to be highlighted because it was just the way things were.

Women were in positions of power and, yes, they were also dressed in incredibly unrealistic outfits, but still this was the '60s and '70s, so it was liberating seeing women who were not in roles portraying the perfect housewife. Not only was one of the central characters a woman but a woman of color. This was a world that, as a young person at the time of the first reruns, I wanted to

The characters all worked together to create a series that honored everyone, but it was the writing that made this series survive the test of time and provide a strong foundation for future series.

I am honored to say one of the early writers, Dorothy [DC] Fontana, was a friend and mentor. Watching the television series in the basement of my Iowa home, I never would have dreamed that one day not only would I be able to go on the set of a "Star Trek" movie, when I had one of my OMG moments, but to be on a first name basis with DC Fontana.

Dorothy passed away in 2019. One of the last times we were together was at a taping of the "Big Bang Theory," which honored "Star Trek" a lot. In fact, as we were walking onto the stage Dorothy pointed out a framed napkin that hung above the entrance. One of the "Big Bang" episodes had Penny give Sheldon – a true Trekkie/Trekker – a gift – a

Sheldon read the inscription on the napkin: "To Sheldon: Live long and prosper ... Leonard Nimoy."

I can't believe I have to explain this but Nimoy portrayed "Star Trek's" Vulcan Mr.

Penny then said, "He came into the restaurant. Sorry the napkin's dirty – he wiped his mouth with it."

Sheldon, his "face twitching with excitement," said, "I posses the DNA of Leonard Nimoy?".... "Do you realize what

Giguere joined The Association in 1964 playing rhythm guitar. # Update Planned on Short Term Rentals

The Los Angeles County Board of Supervisors has continued the discussion on the issue of short term rentals (STRs) that was originally set to be heard at its Sept. 19 meeting. There has not been an alternative date scheduled for the discussion. This decision was made so that more outreach could take place, according to Helen Chavez, spokesperson for Kathryn Barger.

"Pursuant to the Board's motion, the Treasurer and Tax Collector

## Deadline Looms on District Maps

until Sept. 28 to submit their own designed district map for the Glendale City Council to consider and present at its fourth public hearing on Oct. 10.

The City has been considering moving to district elections from the present citywide elections. Many cities have already transitioned to district voting or are exploring the possibility of this process. The majority of the Glendale City Council is in favor of putting the choice of district voting on the March 2024 ballot with the most Councilmember Ara Najarian, who has voiced his objections at numerous council meetings. At Tuesday's meeting Najarian once again shared his opinion about the City putting this option on the ballot.

One of the reasons the majority of the council is in favor of this proposal is to avoid a lawsuit concerning the violation of the California Voter's Rights Act. Several cities have faced lawsuits regarding this issue with one of the most significant filed by the Pico Neighborhood Association vs. the City of Santa Monica that

Court. Santa Monica's at-large, or Residents of Glendale have citywide, elections were challenged. In early 2019 a trial court ruled in the association's favor and ordered Santa Monica to transition to district voting. That decision was overturned by the California appellate court, which was then overturned in August of this year by the Supreme Court of California. However, the high court's decision does appear to leave some wiggle room when it comes to how cities prove they are not violating voters' rights, which Najarian pointed out during Tuesday's meeting.

But the issue does exist and vehement opposition coming from many cities have been and are being sued, and to fight those lawsuits cost the city taxpayers

## Obituary

#### William Thomas Scherkey



Jan. 19, 1942 - Aug. 28, 2023

William "Bill" Thomas Scherkey was born on Jan. 19, 1942 in Detroit, Michigan. After high school Bill served three years oversees as an MP on the Germany-Czechoslovakia border during the building of the Berlin Wall. Bill returned to the U.S. with the GI Bill in hand and attended Western Michigan University where he earned a bachelor's degree in mechanical engineering and a master's degree in industrial management and metallurgy.

Bill worked in the aerospace and defense manufacturing sectors where he oversaw the building of various components for the NASA space shuttle program and stealth bomber. ## What is Being Done About the Traffic in Glendale?

By Mary O'KEEFE

At several meetings, including of the Glendale City Council and miscellaneous community meetings, the topic of traffic seems to always come up -specifically traffic lights.

CVW reached out via email to Emrani to get some clarification on what traffic lights, and traffic issues, were being addressed throughout the

"Development of traffic signal timing plans require various hardware and software components,

communications equipment, data collection and system engineering to operate traffic signals efficiently and effectively," stated Emrani. "The City of Glendale has built a robust and technologically advanced traffic signal system, including the respective equipment and infrastructure that Glendale Public Works director Yazdan allows for evaluation and optimization of traffic signal timing parameters by staff engineers. Public Works recently completed the development of a citywide traffic signal system timing model that includes 157 signalized intersections along major and minor arterial roadways within the City."

that appear to garner a lot of traffic signal complaints, including near the Adventist Hospital/In-N-Out Burger area near the Holly Drive exit of the 134 Freeway and the nearby 134 Freeway entrance. CVW asked Emrani how the department prioritizes specific traffic areas for attention.

"The recently completed traffic signal system timing model allows Public Works engineers to optimize traffic signal timing parameters and traffic signal synchronization within the City of Glendale. We plan on

implementing the optimized traffic signal timing in phases, based on areas of highest land-use density, traffic volumes and freeway access. Phase 1 of the program included optimization of traffic signal timing at 50 traffic signals in the downtown area, along Central Avenue, Brand Boulevard, Glendale Avenue, Broadway and Colorado Street,

There are many areas in the City and was implemented earlier this year intersection to improve traffic safety (2023)," he stated.

> In this area, traffic can back up quickly as drivers wait to turn into the In-N-Out Burger parking lot and drive through, and can also back up with lanes of traffic attempting to get onto the eastbound 134 Freeway.

> Public Works has received a request to evaluate traffic congestion at the Harvey Drive and Wilson Terrace intersection and evaluate impacts from the In-N-Out Burger drivethrough.

> "Staff coordinated with In-N-Out Burger management for internal drivethrough circulation improvements to prevent impacts to the traffic signal operation. In-N-Out has completed the on-site improvements and Public Works staff is currently monitoring traffic signal operation at the intersection," he stated.

> Public Works did recently install a new traffic signal at the Chevy Chase Drive and Sinclair Avenue

at the intersection, which is located at the northwest end of Adventist Hospital.

In addition, "Public Works recently prepared a Local Roadway Safety Plan (LRSP) that reviewed citywide traffic safety challenges and developed proposed countermeasure projects that aim at improving traffic safety along streets that needed it the most," he stated.

Public Works is presently working on implementing these projects with support from a grant from Caltrans and as part of the City's five-year capital improvement program.

"We also manage the City's Neighborhood Traffic Calming Program (NTCP) that provides a mechanism for working with the public to address speeding issues on residential and neighborhood streets with demonstrated patterns of speeding and cut-through traffic," Emrani added.

A short time later, Burbank later located the suspect vehicle, which was abandoned in the City of Glendale. Witnesses in the area reporting seeing two people who matched the robbery suspects' descriptions run from the vehicle onto a neighboring elementary school campus (Benjamin Franklin Elementary; 1610 Lake St. in Glendale).

> A perimeter was established with the assistance of the Glendale Police Dept. A search was performed using police K-9s from both Glendale PD and Burbank PD. During the search, one of the suspects was located but refused to comply with officers' commands. The suspect was ultimately bitten by a Glendale police K-9 before being taken into custody. The second suspect surrendered to officers and was taken into custody.

> Officers performed comprehensive and detailed search of the school campus and the area where the suspects were taken into custody with the assistance of an article-detecting K-9. No weapons were found. However, evidence linking the suspects to the robbery was found, including the victims' property.

> The suspects have been identified as a 15-year-old male and a 16-year-old male, both residents of Los Angeles. Both were arrested on suspicion of armed robbery and transported to a juvenile detention facility.

Formal charges are pending review by the Los Angeles County District Attorney's Office.

against children/elders and contact with minors with intent to commit a sexual offense are examples of offenses subject to Magistrate Review. Magistrates will consider the crime and a risk assessment report to determine whether arrestee should be released with no conditions or determine the least restrictive. non-financial conditions intended to address whether the arrestee is likely to return to court. All offenses in the MR category are designated as zero bail offenses.

As an example of this change, a person arrested for false imprisonment under this new protocol would be eligible for BR. Under the previous bail schedule, the bail amount would be \$50,000. Likewise, a person arrested for theft of an automobile is eligible for BR, while under the previous bail schedule the bail amount would be \$35,000.

This represents a significant change in protocols for all law enforcement agencies in Los Angeles County. The Los Angeles County Police Chiefs' Association (LACPCA) remains committed to the safety and security of our communities. continue to work within the processes set forth by the Superior Court of Los Angeles County and, as a profession, recommendations for improvement at every opportunity.

private insurance and there is a regimented process that applicants go through to attend the spa.

This may sound like a wonderful opportunity for those who can afford it and even parallels the history of the Crescenta Valley and Tujunga that at one time was a beacon for healthy living with clean air and a number of spas. However, this new neighborhood business has residents wondering why they were not informed about it prior to the installation of a sign at the location, and why permits allow for substance rehabilitation.

CVW spoke to one neighbor who is having a difficult time trusting the owner of U Matter Luxury Resort because of the lack of outreach done regarding the resort. The neighbor toured the facility and, though he liked what he saw, he said there were still nagging concerns.

"It was informative," he said of the tour. "We are still not comfortable with the lack of community involvement in the approval process for a business in our neighborhood. We feel like we're at the mercy of just taking [their word] of what the business is going to actually be."

He, along with other neighbors, is concerned with the substance rehabilitation permit that was pulled by the business. Cardenas explained this permit is required by Los Angeles County due to the detox nature of the business but U Matter Luxury Resort is not a rehabilitation center.

The residence is in the unincorporated area of LA County and falls under the jurisdiction of LA County Supervisor – Fifth District – Kathryn Barger.

Barger's office is aware of the concerns of the residents and her office has reached out to the Dept. of Regional Planning (DRP) to follow up on the process. The DRP representatives had told the owner to remove the sign that had been placed at the property because it was in violation of an ordinance.

"The 'resort' is in the process of receiving licensing and certification of its new facility as a non-medical residential rehabilitation facility that can provide specifically approved CA Dept. of Health Care Services (DHCS) scope of services to short-term residents consisting of 1) educational sessions; 2) group sessions; 3) individual sessions; 4) recovery or treatment planning. The site's director of Operations, Prescilla Cardenas, has communicated to DRP that the site is not a medical detoxification or incidental medical services facility," according to Barger's office.

DRP has sent emails to constituents who have emailed their concerns and has reached out to the owner and agent for the U Matter Luxury Resort LLC. A meeting with the owners was scheduled that will include a tour of the facility.

There is an issue of how many people, or clients, will be at the spa. There are six bedrooms that will be available with another bedroom that will be for the facility worker, according to Cardenas.

Barger continues to follow this issue, along with DRP. Cardenas said she was not contacted by any neighbor about the concerns surrounding the resort until she noticed the concerns posted on social media. She invites neighbors who have questions to contact her at prescilla@umattertherapy.com.

Fortunately for the driving policeman, with the first shot he ducked down just low enough as three shots and a lot of glass flew over his head. The police car veered out of control but braked before hitting anything. By the time the officers collected themselves the car was gone.

> Days later they later found the car parked in Montrose but the registration and plates were gone. Neighborhood kids had been playing in the unlocked car and any fingerprints had been messed up.

> Next up, a widow living in La Cañada was headed out to her car at night when she was jumped by two thugs in a homeinvasion robbery attempt. They pistol-whipped the old woman as she begged for mercy. They were gagging her and just were about to enter the house where her daughter and granddaughter were sleeping.

Luckily just then, her son-in- pursuing car pulled up next to four friends, two men and two women. They saw the widow lying on the floor of the garage and rushed to help her. The two hoodlums came out of the shadows with guns drawn and forced the group back into their car. The two criminals squeezed into the back seat and had them drive up Angeles Crest. A couple of miles up the hill they made them pull over, robbed them of cash and took off in their car, leaving them stranded.

More thugs, this time in Tujunga. Two adults, one from Montrose, and two teenagers were cruising around the San Fernando Valley. They picked up a hitchhiker, a Finnish merchant seaman. The thugs pulled a knife on the poor seaman, took his wallet and had him strip off his clothes. They dumped him out half-naked. He managed to call the cops and the police found the thugs cruising in Tujunga. They led the police on a wild 70mile per hour chase through the streets of Tujunga before they were cornered and caught.

Also in La Cañada, a mother and her daughter were coming home late from a basketball game. A car was following them, no doubt driven by thugs. The


There were three other smaller crimes reported that week – two burglaries and an attempt to poison a dog.



## SCARFFEST FOUND AT HALLOWEEN HORROR NIGHTS AT UNIVERSAL STUDIOS HOLLYWOOD

niversal Studios Hollywood is back once again to bring the fear to the fog with this year's Halloween Horror Nights. CV Weekly was invited to come experience all HHN has to offer and, though it has its ups and downs, it brings that classic cold feeling to the pit of your stomach just in time to start the Halloween season.

A particular standout this year is "Monstruos: The Monsters of Latin America," an exploration of Latin American folklore's most terrifying ghosts and creatures. From vampire ladies to giant owl monsters, the best (or rather worst) of ghost stories lurk inside the Cemetery of the Lost. This one was fun and creative in its presentation and monster design, bringing in little details from the lore to inspire the physical space and make it feel really immersive.

Honorable mention goes to individual gags this year rather than individual standout houses. Several of the houses were fine overall with individual moments of sheer terror or unique kills. Chucky in "Chucky's Ultimate Kill Count" has some very inventive unique kills that stick with you after the tour of the house is over. "Universal Monsters Unmasked" has some really cool moments that include The Hunchback of Notre Dame and The Phantom of the Opera, all set to a fantastic new soundtrack from Slash. And "The Last of Us" has a really cool

finale effect that we won't give away, but it definitely turned our heads.

"Stranger Things 4" might have been the most beautiful house this year as it has been in many years. It feels like it is set in a dream, which is what that season of the Netflix show felt like. Bringing that location to life in a physical way was impressive and the photos from this house are the ones I keep going back to because they're just so beautiful. The house missed some iconic moments from the show that it would have been nice to see, but it was a beautiful house throughout with some cool effects of Eleven's standoff with Vecna.

One low point of the night was the "Terror Tram ... The Exterminatorz." An insect uprising led by the bugman Larry Larva is the central theme, placing guests in the middle of a mission to exterminate humans from Earth. It was a house at last year's HHN in Universal Orlando Resort that was well received, but that house had more flair and unique design of its own. Cramming this concept into the airplane crash on the backlot took away much of the appeal from what Florida had and reduced it to just some bug guys on a path.

At the other end was one surprisingly fun addition — "The Purge: Dangerous Waters." This stunt show was set in the Water World amphitheater and was something I wasn't looking forward to ... and didn't expect much from. Boy, was I wrong.

The fusion of the classic Water World

stunt show with "The Purge" movies, all in an enhanced nighttime setting, created a spectacle of fire and laser light shows that was just straight fun. It fits with the HHN feel and is a much better use for "The Purge" than would be a scare zone. This is one not to miss.

Despite being steeped in tradition, Universal Studios consistently surprises its visitors. From the standout "Monstruos: The Monsters of Latin America" to the unlikely hit "The Purge: Dangerous Waters," these attractions show Universal's commitment in pushing the boundaries of horror. The winding maze of the classic "Universal Monsters contemporary Unmasked" and scarefest "Stranger Things 4" continue to prove why Halloween Horror Nights is a must-see event each year.

Tickets are on sale now and selling fast. Wait times can climb into the two-to-three hour range for some of the more popular houses so if you're serious about seeing everything, the Universal Express front of the line pass is the option to choose. Otherwise it's mathematically impossible to see everything on certain nights.



: Refurbished computers are hit-or-miss. You might get a problem-

Your case is extraordinary. product, the replacement will work. You were exceptionally unlucky.

Here's the problem - and it's didn't sell to you directly. It was just the middleman. Your computer came from another company, Blair Technology. Many companies do this, but when they do it's important to remember that the business that sold you the item (in this case Tiger) is the responsible party. So it doesn't matter that one company issues an authorization number and another doesn't. That's not your concern. It's their problem.

Although I don't publish the executive information for TigerDirect, it's fairly easy to find the names of its managers and their

emails online. I would have sent a brief, polite email to one of them, asking them to help you break this logjam. It looks like you tried that but were ignored. I have some additional tips for getting better customer service by using the Elliott Method, my proven strategy for obtaining excellent customer service.

I contacted TigerDirect on your behalf. The company reached out to Blair to address the RMA problem and then refunded your purchase.





# Changes Continue at

On Tuesday night the CV Cham- Lane Motel and most recently the La ber held its first formal board meeting since moving out of the office space we previously occupied at 3131 Foothill Blvd. 'D.' Thank you to Sadler Hall at St. Luke's of the Mountains for accommodating us. Looking ahead I'm hopeful that we can continue meeting there the second Tuesday of the month at 5:30 p.m. Of course, the community is welcome to attend these meetings.

It was an exciting and dynamic meeting. We closely followed a prepared agenda, which sparked conversation. We also welcomed a local resident who wanted to make sure the Chamber took part in ringing the bell regarding the proposed development at Foothill Boulevard and Briggs Avenue.

The property, formerly the May-

Crescenta Motel, is under consideration for a massive development. The proposal includes multiple stories and a reported 80 apartment units a monolith that will most likely overwhelm the area. However, there are hurdles these days to opposing developments that were not in place years ago – particularly the density bonus that is offered to developers. Basically, developers don't have to have a public hearing and don't have to follow most community guidelines (for us in the foothills, that is the Community Standards District). What folks also have to realize is that these mandates come from the state, not the county. Consequently, it will be harder to fight these developments ... though voices should be raised and will be heard. For more infor-

mation, I suggest you read CVTC President Chris Kilpatrick's article on page 8 of this week's paper.

Returning to this week's meeting of the board of the CV Chamber, I want to salute our board members who are eager to undertake the duties that will make this Chamber the vibrant resource it is meant to be. This includes collecting information from our members and the community as to what it is they are looking for in their Chamber. To that end I encourage you to send an email to me that I can share with the board regarding that information.

We will go over that information as we evolve into an organization that best serves our community.


